

Until Someone Loses an I

Melissa "Liss" Haviv, Take Root



Take Root's Executive Director Melissa "Liss" Haviv describes the journey that led her to start the landmark missing-child agency. Melissa was abducted by her mother at the age of 10 and was forced to enter a life of hiding for two years prior to being located. Liss' decade of work with Take Root allows her to shed new light on the often misunderstood issue of family abduction. She will explain how and why the current response to family abductions is failing victims and outline a change that could decrease the incidence rate. This lecture provides foundational information for a subsequent two part workshop on Thursday, Kid Gloves for Handling Abducted Children.

Impact of Exonerations on Crime Victims

Michele Mallin, Survivor Cory Session, Texas Innocence Project Erin Williamson, IFC International

Many people are affected in cases where the wrong person is convicted of a crime: the person wrongfully convicted, the victim, and their families. Timothy Cole died in a Texas prison in 1999 while serving a 25-year sentence for a rape he didn't commit. Nearly a decade later, another man already imprisoned for other







aggravated rapes came forward and admitted to committing the crime for which Mr. Cole was convicted. DNA evidence from the crime was used posthumously to exonerate Mr. Cole. This session will explore the impact of this wrongful conviction from various perspectives. Cory Session is the Policy Director of the Texas Innocence Project and Michele Mallin was the sexual assault victim in that case. They will each share their experiences and the relationship that developed between Timothy Cole's family and Ms. Mallin. This session will also include a report on NIJ-funded research with ICF International on the impact of exonerations on services available (and not available) to victims of crime involved in wrongful conviction cases.
